The Fund for New Jersey Awards \$955,000 in Grants

Princeton, NJ – The Trustees of <u>The Fund for New Jersey</u> awarded \$955,000 in grants to non-profit organizations at their June 2020 quarterly Board meeting. Grants were awarded to <u>15 organizations</u> in the areas of climate change and clean energy, environmental protection, voting rights, criminal justice reform, social justice and civil rights, and transportation.

Kiki Jamieson, President of The Fund for New Jersey, stated, "The Fund for New Jersey is proud to invest in these policy organizations working to offer solutions that address the climate crisis, protect the state's natural resources, improve public transportation, expand voting rights, and promote racial and economic justice in New Jersey."

Grants awarded in June 2020 include:

Criminal Justice Reform, Civil Rights & Social Justice

- A \$100,000 general operating grant to <u>New Jersey Citizen Action Education Fund</u> to advance public policy solutions that promote economic and social justice, improve health care access and affordable coverage, and ensure sufficient revenue to address New Jersey's state budget needs.
- A \$100,000 general operating grant to the <u>American Civil Liberties Union New Jersey</u> to advance its racial justice work in New Jersey over the coming year, with particular focus on advocating for prosecutorial reform, police reform, expanded voting rights, protecting immigrants' rights, and equitable marijuana reform.
- A \$100,000 general operating grant to <u>New Jersey Institute for Social Justice</u> to advance racial
 and economic justice in New Jersey's urban communities, with particular focus on the racial
 wealth gap, voting rights, and police reform.

Voting Rights

A \$75,000 general operating grant to <u>League of Women Voters of New Jersey Education Fund</u> to
protect New Jersey's democracy and serve New Jersey voters during and after the COVID-19
pandemic, including specific focus on communities of color and voters whose first language is
not English.

Environmental Protection

- A \$65,000 general operating grant as part of a three-year grant (year two) to <u>New Jersey</u>
 <u>Conservation Foundation</u> to advance policies that support the rapid transition to renewable energy in New Jersey.
- A \$60,000 general operating grant as part of a three-year grant (year two) to the <u>Association of New Jersey Environmental Commissions</u> to advance state and local policy to improve water quality, protect water supply, and reduce plastics pollution.
- A \$55,000 general operating grant as part of a three-year grant (year two) to New Jersey
 Highlands Coalition
 to protect and defend the Highlands Act and the Regional Master Plan and
 to educate the public and decision-makers about the importance of protecting natural resources
 of the Highlands.
- A \$50,000 general operating grant as part of a three-year grant (year two) to <u>Pinelands</u>
 <u>Preservation Alliance</u> to advance and enforce policies to protect the natural resources of the Pinelands region.
- A \$40,000 general operating grant to NY/NJ Baykeeper to advance its Clean Water Campaign to protect, preserve, and restore the Hudson-Raritan Harbor Estuary.

Climate Change & Clean Energy

- A \$75,000 general operating grant to <u>New Jersey Work Environment Council</u> to advance policies for climate and clean energy, Right to Know, and COVID-19 worker protections, and to provide leadership to Jersey Renews.
- A \$75,000 general operating grant to <u>Environment New Jersey Research and Policy Center</u> to advance equitable renewable energy and transportation policy and provide leadership to Jersey Renews over the coming year.
- A \$25,000 general operating grant to <u>GreenFaith</u> to provide campaign leadership to Jersey Renews' clean energy policy and to engage the faith sector, with a focus on the African-American faith community.
- An \$85,000 general operating grant to <u>Eastern Environmental Law Center</u> to represent environmental and community organizations to address environmental sustainability and climate resiliency issues in New Jersey.

Transportation

- A \$25,000 general operating grant to <u>Regional Plan Association</u> to advocate for policies in New Jersey and nationally to implement the two-phase Gateway transit rail program.
- A \$25,000 general operating grant to <u>Tri-State Transportation Campaign</u> to organize and advocate for a strong and equitable public transit system and to advance climate resilient transportation policies with a focus on environmental justice communities.
